The Open Door Policy is a system used in many YMCA's around the country. Its philosophy is simple—the door is open to anyone no matter their financial ability.

Steps to receive Open Door Price:

1) On the scale, locate your income level and number of dependants in your household. The price that appears in the box is your automatic, guaranteed price.

2) Send in a copy of your 1040 Tax Form (or any other form that can prove your income), Camp Registration Form and \$75 deposit to the Camp Registrar who will register your child for camp.
